President Medford Magill called the Board of Directors' meeting to order at 10:03 a.m. in the Student Center, North Campus, Louisiana School for the Deaf. First order of business was roll call. VICE PRESIDENT'S REPORT:

1. The Constitution requires the appointment of members to the Law Committee by the Vice President. The Constitution requires two (2) Board Members and two (2) members from the membership at large. The two board members are Max Ray and Joe Sarpy. The non-board member are Anthony Mowad and Joe Broussard. By Virtue of his office of President, Medford Magill, is a member ex officio. According to the Constitution, there can be no further appointments. However, this committee will be in need of an excellent secretary. So I have asked Mary Woods to serve as Law Committee Secretary, with the understanding that she is an unofficial non-voting member and further is on the committee to assist with the minutes and secretarial duties. 2. The Law Committee appointments are subject to approval of the LAD Board of Directors.
3. Once we have received approval of our appointments, we are officially ready to begin business.
4. The first item of business will be to consider the new proposed By-Laws which provide for local chapter representation. Joe Broussard gave a report on the new By-Laws at our Convention this summer in Baton Rouge, but the proposals were tabled or referred to the Law Committee. It is the duty of the Law Committee to take action on this.
5. Expenses. We will need funds from the LAD in order to carry out our work. Max Ray has suggested an initial \$500.00 to cover expenses. Max is also appointed by the Chair to handle the Law Committee Fund.
6. Meetings will be held statewide in order to emphasize the statewide nature of the Constitutional Revisions. Tentative meetings are set for Baton Rouge, Oakdale, Opelousas, and New Orleans. When the revisions are completed, they will be distributed to the members of the LAD for their consideration before a vote at the annual convention this summer.

SECRETARY'S REPORT:

1984 LAD Calendar is ready to be printed by Heritage Press. Believes members will enjoy format. Hopefully, calendars will be ready for distribution by December.

TREASURER'S REPORT:

President Magill introduced Joe Broussard, LRID's Representative to the Board. Officers of LRID for 1983-84 are: Father Gerard Howell, President; Lynne Owens, Secretary; Ed Wood, Treasurer; LRID's Representative to LAD's Board of Directors, Joe Broussard.

LRID's President Fr. Howell presented a report to LAD. LRID voted to send a letter to Governor Treen and former Governor Edwin Edwards inquiring about their position for continuous funding and support of the Louisiana Commission for the Deaf. He drafted a letter and request LAD's approval and use of LAD's letterhead bearing signatures of both organizations' Presidents.

Fr. Howell noted that LRID looks forward to working together with LAD and members of the deaf community. He encouraged members to voice their concerns and/or suggestions.

Houston Moss encouraged in-depth publicizing of future meetings prior to date of meeting.

Fr. Howell informed members he also serves on the National Captioning Institute (NCI) Advisory Board. Needs input from the hearing impaired on programs they would like to see captioned. Will attend Board Meeting October 14th and would appreciate input prior to the meeting. Summarized complex procedures of getting the evening news captioned.

Fr. Howell stressed importance of writing letters. Letters to TV stations are effective in aiding TV stations in making decisions.

LOUISIANA COMMISSION FOR THE DEAF

EXECUTIVE DIRECTOR DAVID MYERS' REPORT:

David Myers presented a brief report on LCD's activities. Briefly summarized, LCD is continuing its work to revised bill which prohibits deaf people from serving on juries; develop guidelines to certify interpreters; to encourage various government departments to use interpreters. Max Ray (Delvin Fontenot) moved that we accept members of the Law Committee as appointed by Joe Benedetto, Vice President. Passed.

Joe Broussard (Joe Sarpy) moved that we give \$500.00 to Law Committee to defray expenses incurred during the revision of the Constitution/By-Laws. Passed.

Joe Broussard (Max Ray) moved that the Bayou State Bulletin reserve one-half page for LRID news, if space is available, and include LRID members on mailing list. Passed.

Max Ray (Delvin Fontenot) amended motion to read: in case newsletter is returned and happens to be an LRID member, LRID will be responsible for postage. Passed.

Max Ray (Joe Sarpy) moved LAD join with LRID in writing letters to Governor candidates, Dave Treen and Edwin Edwards, asking their position on LCD and that the letters be written on LAD letterheads with signatures of both organizations' Presidents. Passed.

Joe Broussard (Max Ray) moved to have a separate account for Miss Deaf Louisiana Pageant. Passed.

Joe Sarpy (Delvin Fontenot) moved that LAD select LA Signe Fete (La. Silent Celebration) to perform at the next LAD Convention at the group's own expense. Passed.

Joe Broussard (Delvin Fontenot) moved to amend the motion to read: and that LAD suggest to host club that they might wish to invite the group to perform. Passed.

A motion was made for New Business to be closed. Passed.
