

**LAD Board Meeting
8 November 2014

Pauline Wood (Cleve Cormier) accepted the minutes on 16 August 2014 with some corrections.

President's report:

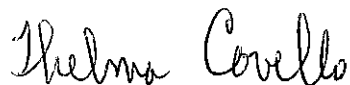
