President's Report:

Cindy Robillard (Wanda Miller) accepted the December 12, 2015 minutes as read with no corrections.

President Houston Moss' Report:

- December 14, 2015 – Participated in NAD Region 3 meeting on webcam
- January 1, 2016 – LAD Super Bingo, volunteered, Bingo did well
- January 4, 2016 – Sent articles from LAD to NAD for NADmag (available to NAD members) regarding "Know Your Rights and Empowerment Training"
- January 9, 2016 – Attended Deaf Grassroots Movement (DGM) Workshop in Mandeville, LA, where 65 people attended.

LAD Members, Jimmy Gore and Jay Isch attended along with John Veazey (Louisiana's own Deaf attorney), Very disappointed that no interpreters showed up the first two days. HB100 with amendment to eliminate the repeal of the Telecommunications Fund for the Deaf passed. It was sent to the Senate to vote.
- February 23, 2016, Sent letter to all House Representatives on behalf of LAD asking to support the amendment.
- February 27, 2016, Attended DGM workshop in Shreveport, Approximately 75 attended.

- March 3, 2016, Sent a letter to Senate Representatives concerning SB 26 (State Bill), proposing to abolish the Telecommunications Fund for the Deaf.
